

## BUCKS GO PRO 2.0

### **What is Bucks Go Pro 2.0?**

The Bucks Go Pro 2.0 corporate internship program is a summer internship program exclusively for Ohio State student-athletes. The internships are offered at various organizations and corporations and provide real world experiences for student-athletes.

### **Who participates in the Bucks Go Pro 2.0 program?**

The program is exclusively for Ohio State's student-athletes.

### **What is the structure of the program?**

The interns are able to start working as early as May 6th, and could work for their respective organization as late as August 7th. The program dates are flexible in order to best accommodate the schedules of the supervisors, while aligning with the start dates of other interns working within the organizations. Interns may work up to 240 hours (minimum 160) over the course of their internship. The daily responsibilities of the internship are decided by the organization. We expect the opportunities to help enhance the intern's professional development and personal growth.

Interns participate in weekly conference calls with Eugene D. Smith Leadership Institute staff members. The smaller group conference calls are designed to allow for dialogue and discussion, while giving student-athletes to opportunity to learn from their peers. Interns attend a networking event where they are given the opportunity to engage with local employers and professionals in efforts to enhance their networking skills. The event is held in conjunction with the Huntington Bucks Go Pro 1.0 program, allowing the interns to network with other student-athletes and athletics staff, as well.

### **Are interns compensated?**

Interns are paid hourly at a rate of 11 dollars an hour up to 240 hours. They are bi-weekly employees and will be paid in accordance with the bi-weekly pay schedule.
